ABOUT THE SPEAKERS

Michelle Epstein

Dr Epstein's research at the Experimental Allergy Laboratory of the Medical University Vienna focuses on the elucidation of the basic mechanisms underlying the initiation and perpetuation of allergic disease.

Todd D. Green

Todd Green is vice President, Clinical Development & Medical Affairs at DBV Technologies. Prior to joining DBV Technologies, he served as site principal investigator on multiple multicentre food allergy clinical trials at UPMC Children's Hospital of Pittsburgh.

Marjolein Meijerink

At TNO, Dr Meijerink is responsible for the food protein allergenicity assessment and the development of guidance on how to identify parameters and how to assess and monitor the safety and efficacy of immune health interventions and exposure.

Kirsten Grinter

Ms. Grinter's current role is Regulatory, Scientific Affairs & Nutrition Manager for Nestlé Oceania. She has been involved with the Allergen Bureau at its inception in 2005 and is passionate about delivering industry allergen management initiatives. Ms. Grinter is the President of the Allergen Bureau and is driving international acceptance of the VITAL risk-based programme, through the work of the VITAL Scientific Expert Panel.

Joseph Baumert

Prof. Baumert's research interests include the examination of the digestive stability of major food allergens and determining how digestion-resistant allergens may impact allergic sensitization to foods; the determination of minimal eliciting doses for specific food allergens; the examination of processing effects on food allergens; and the development and improvement of immunochemical methods for detection of allergenic food proteins.

Paul Turner

Dr Paul Turner is a Clinician Scientist and Honorary Consultant in Paediatric Allergy & Immunology at Imperial College London, and Clinical Associate Professor at the University of Sydney, Australia. His research focusses on the pathophysiology of severe allergic reactions to food. He is a member of the UK Food Standards Agency's Science Council, the FAO/WHO Codex Expert Consultation on Risk Assessment of Food Allergens and leads the EAACI Taskforce on Food Allergen Thresholds.

Bert Popping

Dr Bert Popping is managing director of the strategic food consulting company FOCOS. He previously worked as Chief Scientific Officer and Director Scientific Development and Regulatory Affairs for multinational contract laboratories. Dr Popping has more than 25 years' experience in the food industry and authored over 75 peer-reviewed publications on topics of food allergens, food authenticity, food analysis, validation and regulatory assessments.
